WHAT IS THE PRODUCT?

Type:

Mutual Investment Fund under Luxembourg Law governed by Part I of the Law of December 17, 2010.

Term:

This sub-fund is not subject to any fixed term. The Fund is established for an unlimited duration; it may be dissolved at any time with the mutual approval of the Management Company and the Depositary Bank. The Fund shall be liquidated in the cases provided for in Article 22 of the Law of December 17, 2010. The Management Company may decide to enter into liquidation the Sub-Fund in case of extraordinary events such as changes in the political, economical or monetary situation or when the net asset of the Sub-Fund is less than a minimum level for the Sub-Fund to be operated in an economically efficient manner, as further described in the Prospectus.

Objectives:

The Sub-fund's sustainable investment objective is to invest in a range of assets which the Investment Manager has assessed will contribute to climate change mitigation. Through this objective, the Sub-fund aims to generate capital growth over the long term.

The Sub-fund will seek to achieve its objective by providing risk-controlled exposure to the assets selected which have been assessed by the Investment Manager as being aligned with the transition to a low carbon economy and contributing to climate change mitigation ("climate-aligned") using environmental metrics, through allocating all or substantially all of its assets in accordance with a proprietary quantitative model, the 'Man AHL TargetClimate' strategy. The asset classes selected for investment will be comprised of equities, bonds (government bonds and corporate bonds, including green bonds meeting the ICMA Green Bond Principles) and commodities (via eligible commodity index swaps). The Sub-fund may also invest up to 100% of its net assets in equity index futures, government bond futures, inflation linked bonds, credit default swaps, and commodity index swaps.

The Sub-fund will implement its strategy by investing directly or indirectly - through units/shares of UCITS and/or UCIs - mainly in:

- (i) exchange traded and OTC financial derivative instruments,
- (ii) transferable securities, which may include: listed equities securities and common stock (across all industrial and geographical sectors and market capitalisations) and fixed income instruments (including fixed and/or floating rate, government and/or corporate bonds which may be investment grade, non-investment grade and inflation linked bonds), term deposits, and money market instruments.

The Sub-fund exposure to the above-mentioned asset classes achieved by indirect investments through units/shares of UCITS and/or other UCIs which have also been categorised under article 9 of the SFDR will not exceed 40% of the Sub-fund's net asset.

Direct and Indirect exposure to equities instruments will be up to 100% of the Sub-fund's net assets.

The Sub-fund's investments will not be limited by geographical sector and the Sub-fund may invest globally, including in emerging markets.

In addition, the Sub-fund may have an exposure to below investment grade securities in excess of 30% of Sub-fund's net assets.

The Sub-fund will not invest in asset backed securities ("ABS"), mortgage backed securities ("MBS") nor in contingent convertible securities ("CoCos").

The Sub-fund may also invest up to 15% in money market instruments.

At inception of the Sub-fund and for a period of maximum 6 months, the above described investment policy can be pursued by investing part or all of the Sub-fund's assets in UCITS (including ETF) with similar universe.

The Sub-fund may use financial derivative instruments for investment and risk hedging purposes.

The sub-fund has been categorised as a Sustainable Objective Sub-Fund, as it has sustainable investments as its objective in accordance with article 9 of the SFDR.

The Sub-fund is actively managed. The Sub-Fund is not managed in reference to a benchmark. However, the Sub-fund measures its environmental metrics against the MSCI World Climate Change Index (USD). The Sub-fund does not intend to track the Index and is not constrained by it.

This is a capitalization Unit-Class which reinvests all income generated by the Sub-Fund. You may request to redeem the units held at any moment, in accordance with the Prospectus.

Intended Retail Investor:

The Sub-fund is suitable for investors who look for long term investments and have a preference for sustainable ESG strategies. The investor must be able to accept a certain volatility and the possibility of losing a part of the invested amount. This product is for investors who meet the conditions for accessing the product in question (see prospectus) with any level of knowledge and experience. Investors should understand the product risks and only invest if they can bear potentially substantial losses.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk indicator



The risk indicator assumes you keep the product for a minimum of 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

Specific reasons, such as change restrictions or circumstances outside the control of the Depository Bank, may render impossible the transfer of redemption amount in the country where the redemption is requested. In case of mass redemptions, the Management Company may decide to suspend the redemptions until it has sold the necessary assets. The summary risk indicator ("SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as class 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.

Furthermore, the Management company is liable exclusively for the obligations contracted on behalf of the Sub-Fund with the assets of the same fund. On those assets actions by creditors of the Management company or creditors of the depository or sub-depository are not permitted. The creditors of individual investors are permitted to take action only on the units/shares held by the individual investors. The Management company may in no case use, in its own interest or in the interest of third parties, the assets belonging to the managed funds.
